

Who are “they”?

On Feb 24, 2010, Ron Paul read a prepared statement to the Senate regarding the US government’s assassinations of American citizens. Paul reported that on Feb 3, 2010- Dennis Blair, Director of the National Intelligence Committee admitted in open testimony before the Intelligence Committee that our government has an explicit policy that allows the US government to assassinate American citizens at the government’s discretion. But we do have the power to change it. A State can refuse to follow a Federal Law unless that right of jurisdiction is explicitly provided to the Federal Government by the Constitution. Hawaii has already rebuked the Federal mandate that all citizens must submit to the swine flu vaccination. Seventeen other states have followed a similar route when they moved to allow legal marijuana for medical purposes.

We also need the right to nullify any law or regulation made by any government agency that is not in the best interests of the People. Andrew Napolitano, a retired NJ Judge who is now a commentator for Fox news is beginning a dialogue with several people and organization in the health freedom movement to plant the idea that we must demand a right to nullify unjust laws. He and Ron Paul are appearing in Ohio on March 8th. But the first step is that we must care. We must take the time and energy to create change from the bottom-up. Let’s begin to identify some of the players in this mess.

There are generally two types of marketing: bottom-up and top-down. Pharmaceutical companies use both of these methods. They use commercial television ads to encourage patients to take the information to their physicians as to what kind of medication they want: bottom-up. They, BigPharma, also use top-down marketing by using drug representatives who directly interact with the physicians: top-down. We have been using bottom –up for a long time, using the voices of the People as a way of making a difference. It’s not that we are being ignored at this point, but they are making the laws so quickly and quietly, we are having trouble keeping up.

You see the words “they” and “them” in this message. Let’s stop and define the word “they” in this context. I want to define “they” as any individual or group who puts their own need for power and money in front of the needs of The People. For example: the priority of health care at this point is profit, not health. In that light, let’s look at some “theys”:

BigPharma – look no further than the swine flu fiasco – who benefited? – 80% of the people were wise enough not to be injected with untested—actually proven to be tainted—vaccines. Even those who help create the vaccines came out against it later recanted. What’s up with that? In my mind it just makes the whole mess more sordid. They need to stop using fear and scare tactic to provide \$\$\$\$ as the goal of health care. Question: Why weren’t those who were caught tainting vaccines, punished or taken to task for having a dirty lab? Articles about this suggest that is could not have been accidental; that protocols of safety would have prevented this. People were required to pay for these mandated vaccinations. Faked Research from BigPharma – Scott Ruben, MD confessed that he faked 21 studies for Pfizer. In one study of Celebrex in 2005, Ruben was able to publish his faked study in scientific, peer reviewed, journals. Ruben has reportedly agreed to return the \$420,000 he was paid by BigPharma for these faked studies. He may also face prison and a fine. I bet that never happens. Who is watching these guys; and what about the people taking the drugs he tested, Celebrex, Bextra, Vioxx and others: What about their rights to take medications that have been certified to be safe? Who's watching out for them? What are the rights of The People in all of this?

In Maryland, in November, 2007, parents and children were herded into court under watch of the military with guns and dogs. That information was nearly buried, but it is available on the internet. These kids were vaccinated against the wishes of the parents; and "they" did nothing; likely sanctioned it. There are many more such examples that the internet provides us. But as soon as the renovation efforts of our government begins to raise it head, our communication will be shut down. We must prepare an alternative internet now so that it can be put into place when, not if, this happens.

Faked Research from Scientists and ex vice-presidents – When it came out that this global warming research was faked, why weren't the laws repealed that were based on that research? Why does Al Gore still possess his joint award with the Intergovernmental Panel on Climate Change, the Nobel Peace Prize in 2007?
